



had 67 per cent corruption according to the Corruption Perception Index 2010. He also said that there should be a Bribery Act in the country on the same lines as the one existent in the Unit-

ruption", he said and added that both the giver and the taker should be punished. Alleging that business houses and businessmen were the foremost in offering bribes, he said that practices

such as this could endanger the overall growth of society. He also said that there were efforts made by successive government to curtail the powers of the Lokayukta and all non performing officers were deputed there. He even said that many people would try to carry out personal vendetta against any official who would try and nab corrupt activities by using their weapon of transfers.


